8 REPORTS

8.1 President

The first ride has been run and was very successful given the hot weather, the return to endurance following EI and the challenges of dealing with a smaller venue. A young guy turned up to practise his photography skills, heading out on the track at different points and taking plenty of photos at the ride base. I chatted to him a few times during the course of the weekend and he was absolutely amazed at the quality of our endurance horses, the care that the riders showed the horses and the ability of the horses to compete under trying conditions.

There were quite a number of riders completing their first training rides and it was great to see they be successful. The rider that drew the most attention, and won the encouragement award, was young Nikki who rode the 40km training ride bareback. Her horse had developed a bit of a girth gall prior to the ride so her Mum promptly told her she was riding bareback and off she went. Amazing stuff.

A couple of horses required treatment and the invasive treatment forms will be submitted to the Committee for review at the meeting, as well as the Chief Steward's report.

We will also have to deal with the request from the AERA Committee relating to our Tom Quilty Committee. We all need to get behind the TGC to ensure that the 2009 Quilty will be run in Victoria.

I will present the completed policies (Communication and Discounted Membership) to the meeting for review by all SMC members.

It is good to hear that Adrian has returned home from the hospital and is recovering well. I'm sure you'll all join within me in wishing him a continued speedy recovery and we all look forward to seeing him back at the SMC table when he is ready to return to the fray. I want to thank both him and Sue for their continuing work on servicing our members with logbooks during this period when his health has been less than 100%. He's shown a strong commitment to keeping our members happy.

I have had initial discussions with Jil Bourton about the State of Origin Challenge. We need to come up with some sort of format for this competition and decide on rides close to the border at which the event can be staged.

8.3 Membership Secretary

8.5 Logbook Registrar

Annual Logbook Return (Attch X 1)

Since our last meeting a slow but steady stream of Log Book Applications have been received. Most were processed from the Melbourne Private Hospital during my recent extended stay. I must thank my good wife Sue for bringing the stuff down to me and posting it off after it was processed. The same old problems are being experienced. Forms not filled out correctly, correct forms not being used, information not being supplied etc. It will probably take a little time but hopefully we will get everyone right. I am making some allowances because I haven't been home and we have had an extended break from riding. My biggest concern is the lack of Yearly Registrations compared to last year. I hope members who have not Registered their horses for life and only do it Yearly remember the rule - No Registration –No Ride. I suggest at least another mention in the next newsletter.

The annual logbook returns were discussed. They enable the AERA to keep a current record of competing horses and an archive of retired, sold or deceased horses. In QLD these are submitted annually with membership applications by the members. We will publish these in the newsletter and website after a modification regarding sale details of the horses has been made.

Details of ownership labels and the importance of these was also discussed-we will continue to remind members and ride committees.about ownership label requirements.

With an up coming harness event, the need for Endurance and Novice Harness Horses to have a separate Harness Logbook was discussed. Training and introductory Harness drives are able to be completed on a day vet card. Members of the ride committee were present at the meeting and they will ensure they are familiar with these requirements.

8.6 Calendar Co-ordinator

The Stockyard Hills ride has been approved for 20th April. The small alterations to the Newstead @ Maldon ride have been addressed. Julie reminded Ride Organisers about the application procedures and Carl's role as Insurance Officer. Even small details such as the change of a ride venue need to be forwarded on. Jul;ie also mentioned it was time to start considering the 2009 State Championships so that a suitable date can be applied for. The Newstead/Maldon ride had some small mistakes in the published flyer and it was clarified that there will be offered:

Harness 20, 40, 80km events

Riding 20, 40, 80km events (including Pony Club K Certificate 40km)

The Harness rules are in the Members handbook and they need to be publicised prior to this ride.

Julie also pointed out some of the stationery and forms downloadable form the website are out of date. Jo Brock will be contacted to amend these.

Julie and Carl clarified some of the ride application procedures.. Carl will clarify/simplify the process and report back to the committee.

Discussion was generated regarding the calendar guidelines. Multi day events were welcomed by most as a way to save on fuel and general attendance costs. Discussions also took place regarding the scheduling of more rides and the possible merit of having 1 week spacing as long as the rides were not in the same region.

Chris Gates also reported on emerging trends and figures from the USA (AERC) which indicated older people are more likely to take up endurance riding.

Advertising

Carole Dixon Smith has paid for her first issues advertising and I have forwarded this cheque together with a copy of the invoice to Sandy H. Also forwarded a late payment cheque from Australian Equine Alliance for advertising

in September '07 issue. I will contact them to see whether they are wanting to resume their advertising now the EI scare is over, Catherine McAlpine from Splitters Creek has also indicated she will resume her advertising.

Jan/Feb issue took just on 60 hours work to complete and was posted 15th February.

Chris Gates also reported on a suggestion from a NSWERA member to combine the NSW and Victorian newsletters into a single booklet. Discussion ensued regarding the possible merits and downsides of such a proposal. Some benefits including more information for all, reduced duplication of standard forms and notices. 8.13 Insurance Officer

Carl Adamson tabled a verbal report and described to processes needed to be followed to obtain appropriate insurance for rides.

He also informed the SMC that AON, our insurers do not offer any cover at all for members over 80 years of age. It was agreed that this matter needs to be referred to AERA for clarification and follow up.

8.14 Risk Management Officer's Report

Jenny Moncur had forwarded all SMC members with a comprehensive risk management in sport booklet and also a heat management in sport article. She is currently compiling a Risk Management Policy.

8.15 Ride Reports

Yarrabubba-Lissy Verity

Lissy tabled a written report on the ride which was well attended. Discussion ensued regarding several incidents in the report.

The Committee also feel it would be timely to undertake some education of members and ride organizers regarding vehicles on course.

Lissy advises Parks Victoria will assist the TGC Inc. with providing official identification for officials to avoid these types of occurances.

In Camera discussion took place regarding another incident raised in the ride report.

9 GENERAL BUSINESS

9.1 Ride Delegates

It has been the practice of past Management Committees to appoint an SMC member as a Ride Delegate. This may be an opportune time to review this role and decide if it still has value to our Ride Organisers.

After discussion of this issue and input from present ride organisers it was agreed the delegate role had become obsolete and that the policy be discontinued.

9.2 Half Yearly Memberships/Discounted Memberships

At the August meeting a letter had been received from Geoff Jolly regarding half yearly membership. At the meeting a motion was put, and defeated to allow half yearly memberships. Given the low numbers of members this decision should be reviewed and revisited. Half yearly memberships could be seen as a way to encourage people to join and may result in a full year membership the following year. became a member, i.e. if a person paid a half-yearly membership fee they were still charged a full year's insurance levy. Membership fees for 2008 were not increased to reflect the effort to maintain membership.

After discussion on this issue It was felt the policy should remain as is.

9.5 Awarding points for FEI rides.

More discussion took place regarding this issue. A brief history of the issue was put forward by several SMC members. Informal polling of the attendees at the AGM indicated approximately a 50-50 split when asked if points should be awarded or not.

8.8 Unauthorised On Course Assistance/Driving on course

Several times friends and family of riders have been seen on course in vehicles with out the necessary permission from the chief steward. This has recently come to a head when several groups of riders reported having to negotiate passing a vehicle driven by a rider's family member on a narrow bush trail in a State Forest. The situation was not only dangerous to the horses and riders and occupants of the vehicle but also jeopardises the permit conditions from Parks Victoria that allow our rides to be conducted within these parks.

This item was discussed during the Yarrabubba Ride Report.

8.9 Logbooks issued in incorrect names

The Logbook Registrar has brought to the SMC's attention several horses competing under names and ages other than their registered names and ages.
